We employ a team of professionals in various fields: accounting, human resources and employee affairs as well as tax consulting.

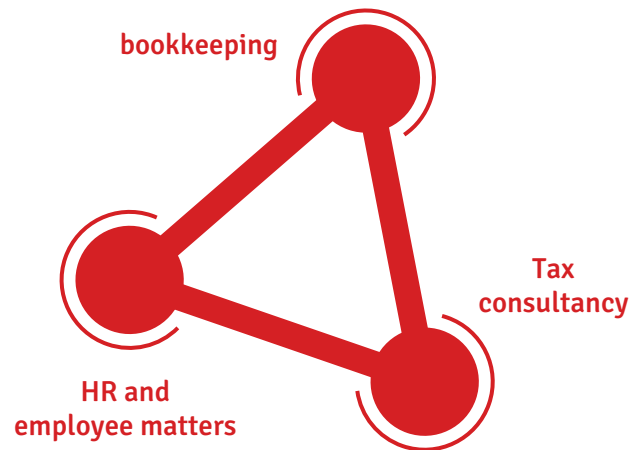

Special working methods

To meet our clients' needs, we cooperate with lawyers, experts and auditors. Thanks to many years of experience we are surrounded by a team of trusted colleagues.

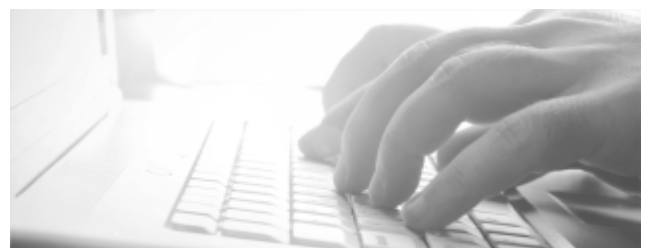


Modern solutions

We use OCR technology, as well as additional applications available online, e.g. for invoicing, running a cash register, etc.

The IT tools we offer make it possible to run even a large company without the client having to build its own technical base and become dependent on a single physical location. Thanks to many years of cooperation with a number of IT companies, we have access to innovative methods that help us more easily and effectively establish communication with data exchange, processing and storage.
